All of aforesaid persons hereinafter called and referred to as the "TRUSTEES (Which expression shall unless repugnant to the context or contrary to the meaning thereof include the survivor or survivors of them and other the Trustee or Trustees for the time being of the Trust herein mentioned) of the SECOND PART.

WHEREAS the Settlor is desirous of establishing a Charitable Trust to be known as "MURAD SHAH EDUCATIONAL & WELFARE TRUST" for the object stated hereinafter and WHEREAS it is intended that the Trustees shall use the Trust Funds hereinafter mentioned for the purpose and hold the same on the Trust hereinafter set out:

WHEREAS the Settlor is possessed of an otherwise well and sufficiently entitled to a sum of Rs. 1500/- (Rupees one thousand and five hundred only) and desirous of setting on trust the amount of Rs. 1500/- in cash towards the corpus of the Trust with the purpose of funding the trust to be utilized for the object set out hereinafter

AND WHEREAS the Trustees here to have given consent to be the office bearer to carryout and administering the affairs of the trust in accordance with the terms and conditions declared by the Board of Trustees.

NOW THIS DEED OF TRUST WITNESSES AS FOLLOWS:-

The Settlor of this Trust do hereby declares Rs. 1500/- (Rupees one thousand and five hundred only) as trust property and also such other assets into which a trust property and/or a part thereof say from time to time converted varied or exchanged together with additions and accretions thereto arising there in trust for accomplishing the objects setforth herein. The Settlor hereby conveys transfers and assigns to the trustees the above property with the powers and subject to the provision hereinafter contained concerning the same.

2) **REGISTERED OFFICE:-** Registered Office of the Trust:- At + P.O + P.S - Bankey Bazar, Distt-Gaya (Bihar), INDIA, Pin-824217.

The Board of Trustees will also be entitled from time to time to transfer the Registered Office of the Trust to any other place.

3) **DEFINITIONS**:- In the Deed of Trust unless there is repugnant to or inconsistent with the subject of context, the following words shall have the hereby assigned to time.

(a) "TRUST", shall mean the "**MURAD SHAH EDUCATIONAL & WELFARE TRUST**"

(b) "TRUST PURPOSES" shall mean the objects set out under Clause 4 of this Deed.

(c) TRUSTEES - The Trustees means Trustees for the time being of the Trust.

(d) "TRUST FUND/PROPERTIES", shall mean the money, securities and other assets, whether movable or immovable

4) **OBJECT OF THE TRUST**:-

a) To open and run a School, educational and Vocational Institution and get them affiliated with concerned authorities of state Govt or Central Govt, which shall be opened to students of all communities in hereby and salubrious surroundings with objects interalia to impart to the students of the said School, Institute, literary, Scientific, religious, physical and other kinds of education, including Socio-cultural development of the surrounding region.

b) To establish, erect, equip and maintain or contribute towards establishment, erection, equipment and maintenance of colleges, schools, bal-mandirs, libraries, free reading rooms, gymnasiums, swimming pools, hospitals, dispensaries, medical clinics-including clinic for tuberculosis patients, nursing homes, maternity homes, orphanages, home for widows, destitute or other unattached woman, vikas-grahas and charitable institutions for relief the poor, education, medical relief and advancement of other objects of general public utility not involving the carrying of any activity of profit

c) To engage teachers, instructors and experts of good moral character and conduct able to impart efficiently and economically up to date instructions to pupils and students in modern science, industrial avocations, research work, intellectual and other useful pursuits.

d) To Create public awareness and make people understand theirs constitutional rights and help them get benefits from several governmental and non governmental schemes of public welfare and utility.

d) To develop a healthy as well as critical attitude towards the development of mental, physical and moral uplift of students and also those connected with the institution and also work as consultancy for development of student in the field of education and their job placement.

e) To establish, acquire run and aid schools, colleges and institution at any place or any state for the use of students and staff of the schools established or run by the trust and generally for diffusion of knowledge among the public.

f) To charge moderate tuition fees and otherwise recoup themselves for the outlay and expenses incurred in the up-keep and maintenance of the institution establishing or about to be established under this deed and net fee shall be utilized for the object of the trust or for general public utility

g) To train and equip use pupils as to be self sufficient in an honorable and decent way of life so as to develop into good, healthy and progressive citizen.

h) To encourage sportsmanship and adventurous spirit of the pupils and those connected with the institution and among in contact with them, and to participate in games of skill and powers.

i) To promote and inculcate the dignity of labour, the appreciation of intellectual gifts and talents of all kinds.

j) To develop disciplinary conduct and a habit to observe the rule of law and self-restraint.

k) To establish, maintain and/or grant studentships, scholarships and other kinds of aid to deserving students, including supply of books, stipends, medals and other incentives to study.

l) To accept donations, grants, presents and other offerings and to deal with the same for the purpose of the trust.

m) To invest, dispose of, transfer or otherwise deal with the subject matter of the trust in such manner as the trustees should deem fit so as to enable the society to carry on the objects of the trust effectively.

n) To undertake integrated rural as well as urban development projects for overall socio-economic development of the villages such as schedules caste, schedules tribes, backward class, rural women, poor and down trodden children, development of cooperatives, drinking water, low cost housing facilities, health for down trodden of weaker section etc and establish orphanages, old-age homes, leprosy rehabilitation centers, home for widows, aged, helpless and people of weaker sections, to come out with deliverance from the fallen condition.



e) To do all other acts, deeds and things of general public utility as may be necessary or deemed expedient to carry out all or any of the objects, aforesaid.

p) All the incomes, earnings, movable/or immovable properties of the Trust shall be solely utilized and applied towards the promotion of its Aims and Objects only as set forth in the Deed of the Trust and no profit thereof shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or in any manner whatsoever to the present or the past members of the Trust or to any person claiming through any one or more of the present or the past members. No members of the Trust shall have any personal claim on any movable or immovable properties of the Trust or make any profits, whatsoever, by virtue of this membership.

5) BENEFICIARIES:-

Beneficiaries of this Trust are the persons of general public of Union of India and Abroad without any consideration of sex, caste persuasion and religion.

6) BOARD OF TRUSTEES:-

The management and control of the Trust and the Trust properties shall vest in the Board of Trustees which shall comprise of not less than five and not more than eleven trustees including the Chairman cum Managing Trustee. All the Declarants herein will be the herein will the First Trustees. The Board of Trustees shall determine the strength of the Board from time to time.

The following Trustees as Office Bearers of the Board of Trustees will manage the Trust:

7. TENURE OF THE BOARD OF TRUSTEES:-

i) The tenure of the first Board of Trustees shall be for a period of five years and provisions for retirement of such Board of Trustees shall be applicable in respect of them only after first five years.

ii) The Trustees co-opted shall hold the office only for three years and are liable for retirement. The Trustees whose term of office expires after the period of five years are eligible to be co-opted as transfer again by the existing Trustees. The Trustees may if he so desires, resign his trusteeship even before the expiry of the terms of his trusteeship.

The Trustees shall appoint one among them as President of the Trust, Sayeeda Khanam shall be President cum trustee of the Trust.

i) The President shall act as chairman at all the Meetings of the Trust. In the absence of the president at any Meeting, the Trustees present may elect one among themselves as chairman of the Meeting

8) POWER OF THE BOARD OF TRUSTEES:-

The Office Bearers of the Board of Trustees collectively shall have the following powers:-

- i) To receive money on any other assets movable or immovable in any shape or form to as and when given by the author of this Trust or any other persons, government agencies, quasi-government of private bodies, institutions, societies, trusts and so on a gift or donation and to hold it same as part of capital funds or corpus of the Trust.
- ii) To make donation or contributions for the objects of the Trust.
- iii) To acquire on lease or by purchase or otherwise to sell, mortgage, lease out, transfer in any other manner properties movable or immovable to construct building and to carry out any other business for improvement of the Trust.
- iv) To invest the Trust Fund in any of the securities specified in section 20 of the Indian Trust Act, 1882 and prescribed under section 13(5) of the Income Tax Act, 1961 and in any Nationalized Bank carrying on banking business.
- v) To file income tax return by the Board of Trustees or through their attorney as the case may be subject to satisfying the condition laid down under section 11, 12, 12A, & 13 of the Income Tax Act, 1961 so that the income of the trust may be exempted from income tax for each and every assessment year and donation made to it by the general public and other institutions be eligible for free education under sec 80G of the Income Tax Act, 1961.

9) POWER AND DUTIES OF THE PRESIDENT:-

- i) To conduct and preside over the meeting of the Board of Trustees.
- ii) At the time voting on any matter/subject (Except Election), if the total votes of the groups of member happen to be equal in member, the President has the power cast an extra vote to decide the matter/subject.
- iii) President shall have the power to allow inclusion of any subject/matter in agenda for the discussion in the course of proceeding/meeting.
- iv) President shall guide, supervise and direct all the activities of the Trust.
- iv) To Board of Trustees may cast upon such other duties.

10. POWER AND DUTIES OF THE SECRETARY

- i) The Secretary shall be elected by the members of the trust.
- ii) The Secretary shall attend to the day-to-day management of the affairs of the trust like correspondence, etc, subject to the control of the Governing Body of the trust.
- iii) The Secretary shall maintain proper accounts in respect of the transactions of the trust and be responsible for the preparation of the financial statements of the trust whenever necessary with the approval by president/trust.
- iv) The Secretary suggest, guide and direct different committee / sub-committee for the making the Trust self sustainable.
- iv) The Secretary shall have authority to put signature on all legal, formal or other documents of the Trust.
- v) The Secretary shall have power to appoint, fix remuneration, give increment, suspend and terminate their employees with consultation of Board of Trustee.
- vi) The Secretary shall be at special liberty to spend for the purpose of the Trust at any time sum upto Rs 20,000/- (Rupees Twenty Thousand only) without previous approval of the Board of Trustee.
- vii) The Secretary shall have a general administrative control over the work of the trust.

11) POWER AND DUTIES OF THE TREASURER

- i) All funds of trust shall remain under the care and management of Treasurer.
- ii) Treasurer shall maintain the accounts of all money which is received and/or paid by him/her on behalf of the trust.
- iii) Treasurer shall make disbursement in accordance with the direction of the Governing Body.
- iv) Arrange annual audit of the account by the auditor duly appointed by the trust for the purpose.



v) File return of Income of the trust with the Income-Tax authority as prescribed by the rules in this regard.

vi) Prepare annual budget for the approval by the trust.

All the above power of the Treasurer shall be carried out in consultation with the Secretary.

12) APPOINTMENT OF NEW TRUSTEES:-

Subject to the provisions contained in Clause 4 mentioned above, the appointment of new trustees shall be governed by the rules as follows:

a) After the completion of the tenure of office of the Trustees, they shall retire but shall be eligible for re-appointment.

b) In case of vacancy/vacancies, new trustees shall be appointed by the Board of Trustee from among the representatives of voluntary organizations, funding agencies or any other independent individual and experts in the field of development, finance, legal and other related matters.

c) Filling in of vacancies shall be by a decision of the Board of Trustees. As far as possible, efforts shall be made to fill in the vacancies by unanimous decisions failing which the majority decision shall prevail.

d) If and as often as the trustees of THESE PRESENTS shall die or retire or refuse or become incapable to act in the Trust thereof shall take the benefit of the insolvency law for the time being in force or if any trustee shall remain absent from three consecutive meetings of the trustees without leave of absence, then and in every such case, it shall be lawful for the surviving or continuing trustee or trustees for the time being of THESE PRESENTS to appoint new trustee so vacating their offices in the Board of Trustees.

13) EFFECT OF APPOINTMENT OF NEW TRUSTEES:-

Upon every such appointment made in pursuance of the last foregoing clauses thereof, the newly appointed Trustees shall have powers and authorities of a Trustee under THESE PRESENTS.

14) APPOINTMENT OF SPECIAL COMMITTEES:-

The Board of Trustees shall be entitled from time to time to appoint with or without remuneration and on such terms and conditions as they may think proper, to appoint additional/special committee as they may think proper to function under the Authority and control of the Trustees for carrying out the objects of the trust of these presents or the management thereof and invest them with all such powers including power to incur all such expenditure as may be necessary for carrying out the object of the Trust.

15) DETERMINE ALL QUESTION OF DOUBT OR DIFFICULTY:-

It shall be lawful for the Board of Trustees to settle and determine all matters of interpretation of THESE PRESENTS as well as matters of difficulty, doubt or dispute and all questions arising in the course of or incidental to the administration, management and execution of the trusts and powers of THESE PRESENTS and any such settlement or determination shall be valid, binding and conclusive and shall not be objected to or re-opened upon any ground whatsoever.

16) COMPROMISE:-

The Board of Trustees shall have full powers to settle compromise or compound out of court, all suits, action and other proceedings and to settle all or other proceeding, difference of demand and adjust the settlement of all accounts relating thereto as fully as if they were absolutely entitled to the trust fund and without being answerable for the loss occasioned thereby.

17) PURCHASE, HIRE OR TAKE ON LEASE:-

The Board of Trustees shall be entitled to purchase or hire or to take on lease a property or properties for the purpose of carrying out the objects of the Trust hereby created.

18) POWER TO BORROW:-

The Trustees may by the consent of a majority of them raise or borrow money required for the purpose of the trust on a mortgage or pledge of the trust property or any this part of or without any security and at such rate of interest and on such terms as they may think fit and proper

19) INVESTMENT OF TRUST FUND:-

All money forming part of the Trust Fund and requiring investment shall be invested in any of the Securities authorized by law for investment of Trust Funds which are permissible under Section 11(5) of the Income tax, 1961 or shall at their discretion sell/or realize the same or any part thereof.

20) BANK ACCOUNT OPERATION:-

The Trustee may open and operate a Bank Account with any Nationalized or Scheduled Bank/s or Post office/s and resolution authorized by the name and style of the Trust. All the transactions shall be made under the signature and seal of jointly three office bearers of the following:-
President, Secretary, and Treasurer.

21) ACCOUNT AND AUDIT:-The Trustees shall maintain regular accounts of the trust funds and shall get the same duly audited by a firm of Chartered Accountant. The Accounts and Audit Report and report of the Trust shall be made up at least once in a year covering the accounting period as may be determined by the Board of Trustees from time to time

22) SELL THE IMMOVABLE PROPERTY AND MANAGE:-

The Board of Trustees can dispose of assets of the Trust for the interest of the Trust after getting 2/3rd majorities.

23) AMENDMENTS TO THIS DEED:-

The Board of Trustees shall have the power to make or alter such rules and regulations with regard to the conduct of this Trust from time to time to such extent and in such manner as they may deem fit subject to the condition that they shall not be inconsistent with the objects of the Trust.

24) POWER TO MAKE RULES AND REGULATIONS:-

In addition to the aforesaid rules, the Trustees, shall from time to time, be entitled to make rules and regulations for the administration and management of the Trust of THESE PRESENTS and all matters incidental to or concerning the same PROVIDED, such rules and regulations shall not be repugnant to or be inconsistent with the provisions of the purposes of the Trust thereof.

25) AMALGAMATE OTHER TRUST OR VICE VERSA:-

The Trustees shall be at liberty to allow or to be allowed and permit, or to be permitted to amalgamate or to be amalgamated with any other Trust, Institution or Charity, in any areas or area whose objects are the same or similar to those of THESE PRESENTS, PROVIDED, they are not inconsistent with or repugnant to the objects hereof.

26) REMUNERATION OF TRUSTEES:-

The Office Bearers of the Trust shall be honorary and any person in the Board of Trustee in any capacity will not be entitled to draw any remuneration for the performance of his/her duty. However they may be reimbursed for the actual expenses in carried by them, while discharging their duties for the achievement of the aims and objects of Trust as sanctioned by the Board of Trustees from time to time.

27) DISSOLUTION:-

In the event of dissolution of the trust, after payment of all liabilities, the balance assets of the trust shall be transferred to other trust or institution having similar aims and objects.
