The TRUST is hereby constituted as an irrevocable TRUST and it shall be more particularly-known as **"RATHAUR EDUCATIONAL TRUST"**.

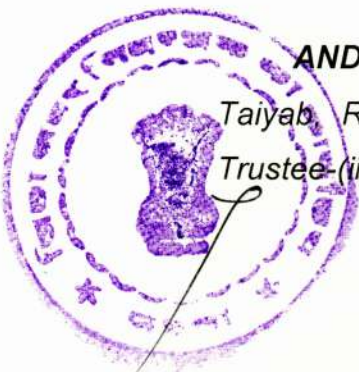
The TRUSTEES may change the name of the Trust if they mutually so decide in future.

The TRUSTEES hereby declare that they and the Survivor or survivors of them or other Trustee or Trustees there for the time being hold the said sum of **Rs.1,05,000/- (Rupees One Lakh Five Thousand)** only made over by the settler to the Trustees as aforesaid and all Gifts, contributions, subscriptions, donations, bequests and other money or properties as and when the same shall be paid to or invested them and the moneys, investments and properties as from time to time representing the same upon Trust to apply the same for the benefit of poor and weaker sections for improvement in their social, economic, cultural and environmental condition and their linguistic, religions and educational development and also for -the-advancement of any other object of their general utility within the State of Bihar (not involving the carrying on of any activity for profit within the territory of India or for charitable purpose which tends development of Theosophy observing the secular character of the nation and for such purpose (without restricting the generality of the foregoing objects to within the State of Bihar do all or any of the following:-

- (i) To undertake projects, programmes, Schemes, relating to Technical, education such as Hospitals, Charitable Dispensaries, Medical Aid Centers, any other Children, maternity Homes, Nursing Homes, Child Welfare Centers, Sanitarium and other Institution of similar nature and N.C.V.T., I.T.I., Engineering Colleges.

(ii) To undertake projects, programmes and Schemes, relating to technical and professional education, scientific enquiry, and research and to establish maintain and administer academic institutions under Article 30 (i) of the Constitutions of India for imparting Modern Technical and Professional Education to the deserving youths in the Field of Management, Education, Science and Technology Polytechnic, Information Technology, Computer Training Center, Medical College and Hospital, Dental College and Hospital Research Centers, Training Institute, Institute of Business Management, Teachers Training College, Law Institutes and other Institutions of similar nature. So that the deserving young after being trained at these institutions may get employment in their respective fields and thereafter they may substantially contribute to the development of the nation as worthy sons and daughters of India.

(iii) To help, aid, assist, undertake, establish and maintain and administer under Article 30 (i) of the constitution Schools including public schools, Colleges for imparting modern general, vocational, - Industrial, Technical Physical, mental moral, Education to the needy and deserving youth for the members of Education, to the needy and deserving youth for the members of Education, Culture, Language, Art, Science, Health and to assist and provide financial assistance to the poor and other people for in other causes of their general utility.

(iv) To aid, assist and help deserving and poor people particularly in rural areas within the territory of India in connection with their personal, social and cultural needs including health, education, marriages and others.

(v) To found, assist and support, establish and maintain, libraries and Reading rooms and to establish and maintain Boarding Houses or to assist such institutions.

(vi) To provide for endowment, stipends, scholarships and other, allowances to deserving and needy students for promotion and encouragement of Educations.

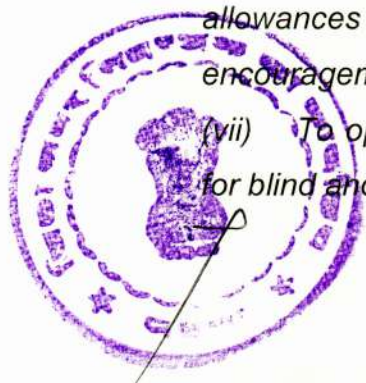

other training or to render assistance to any such existing institution or institutions.

(viii) To maintain, contribute or to give aid to any existing medical, technical professional, academic or Social Institutions or any charitable Institution with philanthropic purpose which may be in the general interest of the poor people.

(ix) To maintain, aid and assist the institution or institutions carrying out activities for National Integration and reservation of secular character of the Nation.

(x) To do all such acts and things as may be conducive to the well being of the society in general and upliftment of the social Educational, Cultural, Linguistic or economic condition of poor masses in particular.

(xi) To undertake project programme and schemes for providing free formal and non "format education to the poor and illiterate children belonging to urban, slum, backward rural and tribal areas who for social economic reasons are not attending schools.

(xii) To undertake projects schemes for providing minimum basis literacy skill to the illiterates through setting up adult educations and non-formal education centers in urban slum, backward rural and tribal areas.

(xiii) To accept donations (in cash- or kind) subscriptions, grants, presents and collect dividends, rents, interests, and other income of the Trust fund etc., for being utilized to further the objects thereof.

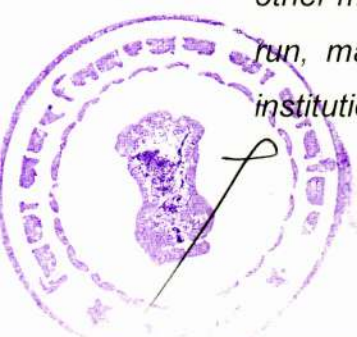

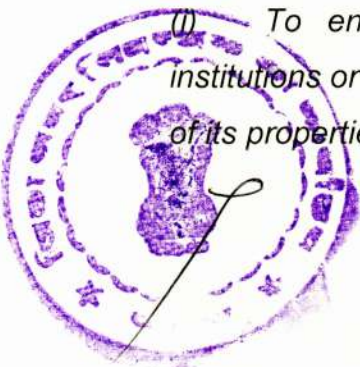

MANAGEMENT OF TRUST

The General Management of the Trust for the purpose of managing the affairs and properties and carrying out the objects of the Trust aforesaid shall be vested in the Board of Trustees consisting of not less than three trustees and not more than seven trustees.

The Board of Trustees shall have one Chairman who shall be the principal executive officer of the Trust and one Secretary & one Treasurer who shall be the executive officer of the Trust. The First Chairman of the Trust shall be **MR. RABINDA KUMAR (SETTLER)** who holds office of the Chairman of this Trust for life and the First Secretary the Trust shall be **MRS. RANI KUMARI**, who holds officer of the Secretary of this trust for life and First Treasurer of the Trust shall be **MRS. KALYANI SINGH** who holds the office of the treasurer for life. All three such as the settler, the Secretary and the Treasurer may nominate one of the trustees as his successor. The Trustee so nominated shall enter into the office of the Chairman and the Secretary/ Treasurer/Treasurer after the life time of the present Chairman and Secretary/Treasurer and If they fail to nominate their successor during their life time in that event after their life time the remaining Trustees shall elect one amongst themselves as the Chairman of the Board of Trustees and one amongst themselves as the Secretary/ Treasurer and without prejudice to the generality of the objects and powers above mentioned, they shall have to do all or any of the following:-

(i) To enter into contracts and borrow money from Banks, institutions or individuals for the purpose of the Trust and management of its properties and assets.

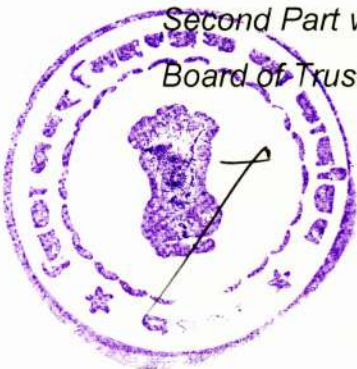

- (ii) To engage consultants for specific purposes on such terms and conditions as they may deem fit.
- (iii) To enter into agreements with organizations and individuals for execution of any projects that may be undertaken to taken the Trust from time to time.
- (iv) To make rules and regulation from time to time for the management and conduct of the affairs of the Trust and it's properties and assets.
- (v) To appoint/select a trustee as a Treasurer, who will prepare Annual Budget, monthly and yearly expenditure statements get the audited by auditor duly appointed by the Board of and place them before the Board of Trustees for approval. The Treasurer is responsible to maintain cash book and prepare vouchers for the payments made, receive contributions, sign acknowledgements for the amounts or articles received by the Trust and prepare monthly and yearly statements of revenue and expenditure, as well as, the register of assets of the Trust and place them before the Board of Trustees for their approval.
- (vi) The Secretary shall be also responsible for the day-to-day administration activities of the Trust. The Secretary shall deal with correspondence received by the Trust, send replies in consultation with the Managing Trustee, Vice President and/or the Treasurer where necessary. He/she is responsible for the safe custody of all the properties and records of the Trust. The Secretary shall represent the Trust in all legal matters, sign the papers related to legal cases, attend to courts or represent the Trust in Government offices.

NUMBER OF TRUSTEES, THEIR TERM AND POWER TO CO-OPT.

The Trust will be managed by a Board of Trustees consisting of not less than three trustee and not more than Five trustees. The parties of the Second Part will be the First Trustees and shall automatically form the Board of Trustees.

The Board of Trustees shall have the power to increase the total number of Trustees upto the maximum number stated above and fix their term as per provisions contained herein.

Any Trustee may retire from the Trusteeship hereof by giving two calendar months' notice in writing of his or her intention to do so, to the Board of Trustees and after the expiry of the period of notice, the Trustee giving the notice shall ipso facto cease to be a Trustee of these presents. Any vacancy caused by death of any one of the First Trustees, or any vacancy caused by the resignation of any of the Trustees, may be filled up by co-option by the Board of Trustees.

The Trustees who are not the Chairman, The Secretary. The treasurer and First Trustees shall hold office for a period of one year from their date of appointment by the Trustees. At the end of this one year period, the Board of Trustees may reappoint them, for subsequent term or appoint other persons as Trustees in such a manner that the total number of Trustees does not exceed the approved maximum number of Trustees.

The Chairman and The Secretary, The Treasurer mutually shall have the power to remove a Trustee-suffering from physical or mental disability or if he/she is accused of misfeasance of trust funds or property or misconduct, after satisfying himself on enquiry and such action of the Chairman and The Secretary, The Treasurer Trustee shall be final.

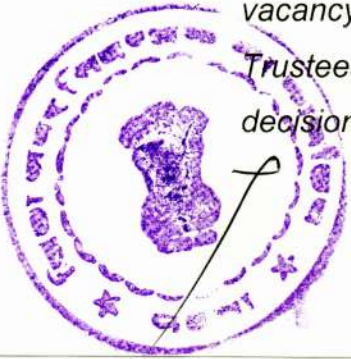

During the time when a vacancy is yet to be filled up, the remaining Trustees shall act as "Full Board", subject to the presence of Quorum in the meetings. 4. POWER OF TRUSTEES:-

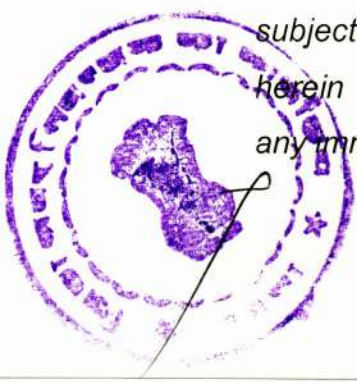
The Trustee will also have the following powers:-

- (i) To apply the whole or part of the income or accumulation thereof or whole or part of the corpus of the Trust properties for one or more of the objectives of the Trust as the Trustees may from time to time determine.
- (ii) To amalgamate the Trust with any other Trust or Society for wholly public charitable purposes.
- (iii) To covert and get in the Trust properties and/or to vary the investments for the time being.
- (iv) To invest and keep invested the Trust properties in the purchase of immovable properties or in other assets specified in section 11(5) of the Income Tax Act, 1961 and to alter vary and transpose such investment from time to time as the Trustees shall, in their absolute discretion, think fit. In any case the funds of the Trust "shall not be invested in any of the manner which is not permissible by relevant provisions of Income Tax Act, 1961 applicable at any given time.
- (v) The Trustees shall have powers to sell or assign any movable and immovable property or properties for the time being forming part of the Trust Fund either together or in parcels and either by public auction or private contract and either with or without any special or other stipulations as to title evidence of commencement of title or otherwise and to by in or rescind or vary any contract for sell or to re-sell without being made answerable for the loss occasioned thereby and for the purpose aforesaid or any of them to execute and do all such assurances, acts, deeds and things as they shall think fit and out of the moneys which shall arise from any such sale for the interest and of the Trust or otherwise in or about the execution of any of the Trusts or powers of these presents and shall stand possessed of the residue of the said moneys and also of the rents and profits of the said premises or of the unsold part thereof for the time being upon such Trust and subject to such powers, provisions, agreements and declaration as are herein declared PROVIDED, always that the Trustees shall manage any immovable property or properties for time being forming part of the

(vii) To open accounts with any Bank or Post Office for the purpose of keeping the money of Trust, to operate such accounts including ever draft accounts and to give instructions to the Bank or Post Office to provide for opening and operation of such accounts by one or more constituted attorneys' agents appointed by the Trustees.

(viii) To engage, constitute attorneys or agents and to delegate to such attorneys or agents all or any of the powers vested in them under these presents from time to time and remove such Attorneys or agents and to engage other or others in their places.

(ix) To make, vary, alter or modify schemes, rules and regulations for out the objects of the trust and for the management of the affairs thereof and running any institution in furtherance of the objects of the trust and otherwise for giving effect to the objects of the Trust.
